Terms and Conditions

The Pro Kabaddi League Contest 2015

Eligibility

- The contest is applicable for sellers from Hyderabad who register their business with Flipkart before 29th July and sellers from Delhi, Mumbai, Pune and Bangalore who register their business with Flipkart before 31st July.
- The citywise contest period is as follows:
 - O Hyderabad 27th 29th July
 - O Delhi, Mumbai, Pune, Bangalore 27th 31st July

How to participate

- To participate, sellers registering their business with Flipkart from the aforementioned cities have to complete the following during the specified contest period of their respective cities
 - Complete the registration process
 - O Upload scanned copy of required business documents (VAT, PAN, Business Address and Bank details) as asked for
 - Complete the contest form available on the welcome page post completion of registration
- For sellers who registered their business with Flipkart during the contest period, entries in the contest form should be original and of less than 150 words.
